

Special Visiting Schedule and Procedures

Visiting schedule and procedures have been modified in response to the COVID-19 pandemic. Please review and familiarize yourself with the revised schedule and procedures for the visiting institution prior to your arrival to expedite the screening process in the Front Lobby and/or screening site.

1. All visitors are required to wear a mask or face covering prior to entering the Front Lobby or screening site and at all times while on institution property. The mask or face covering must cover the nose and mouth.
2. The mask or face covering should be plain (no writing, no pictures) and cannot be bandana material or style.
3. All visitors are required to clear a temperature check and complete a symptom screening form prior to visitation.
4. Visitation is noncontact. Physical contact is strictly prohibited at all times. No embrace/no kiss at the beginning of the visit. No holding of hands.
5. A distance of 6 feet between the inmate and the visitor(s) must be maintained throughout the duration of the visit.
6. Any violation of the noncontact protocols may result in the visit being terminated.
7. The children's play area will be closed.
8. Vending machines will be closed.
9. Social distancing may cause the number of visitors per inmate to be limited.
10. Review the attached schedule for revised days of the week, hours, and length of visitation.

Your adherence to these rules is appreciated for the safety of the inmate population and the public.

USP Atwater Visitation Procedures

- Visitation at USP Atwater will begin on Sunday, October 4, 2020. Visiting hours are: 8:30 a.m. to 9:30 a.m.; 9:45 a.m. to 10:45 a.m.; 11:00 a.m. to 12:00 p.m.; and 12:15 p.m. to 1:15 p.m.
- Visiting will be conducted at USP Atwater on Sunday, Monday, Thursday, Friday and Saturday, and by inmate housing unit assignment.
- Only four (4) inmates may visit at one time, and each inmate may visit with up to four (4) visitors per visit.
- All visits will be for one (1) hour only.
- Inmates may visit two (2) times per month.
- Inmates who are on visiting restriction, or who are in isolation/quarantine may not visit.
- All visitation is NONCONTACT.

SCP Atwater Visitation Procedures

- All visits at SPC Atwater will be conducted in the SPC Visiting Room. The outside visiting area will be closed. Social distancing between visitors and inmates will be enforced. Reminders of no touching, etc. will be made inside the Visiting Room.
- To ensure six (6) feet of social distancing, chairs will be arranged prior to visiting. Visitors will be directed where to sit by staff. There will be no tables placed in-between the chairs, as no food or drinks are permitted.
- Due to the amount of space inside the visiting room, the number of visitors allowed to visit any inmate will be limited to four (4). A maximum of seven (7) SPC inmates will be allowed inside the visiting room at any given time.
- Each inmate will be allowed two (2) social visits per month, so as to allow for the opportunity of all SPC inmates to receive a visit.
- SPC visiting will be limited to the weekends and holidays.
- SPC Visiting Hours are 8:30 a.m. to 10:30 a.m.; 10:50 a.m. to 12:50 p.m.; and 1:10 p.m. to 3:10 p.m.
- All visitation is NONCONTACT.
