#### COVID-19 VISITING PROCEDURES

Effective October 13, 2020, Federal Correctional Institution (FCI) Danbury will begin non-contact social visiting for all inmates not on quarantine or isolation status. The following procedures and guidelines will be followed and there will be no exceptions to this schedule.

There will be no physical contact during any visit. Each inmate will be permitted to visit with two (2) adult visitors over the age of 16. No photographs will be authorized during any visit. Vending machines will not be operational, so visitors will not be permitted to enter the Visiting Room with any money. Restrooms will not be available for visitors in the Visiting Room. Visitors may utilize a restroom in the Front Lobby before entering or after departing the Visiting Room.

At the FCI, social visits will be conducted Monday through Friday, 8:30 a.m. to 2:45 p.m. Social visits will be limited to one (1) hour, as to allow all inmates two (2) opportunities per month to receive visitors. Social visits will not be scheduled on federal holidays. Visiting will be conducted as a cohort; only one housing unit per day to limit potential exposure.

At the Federal Satellite Low (FSL), social visits will be conducted biweekly on Tuesday and Wednesdays, 8:30 a.m. to 2:45 p.m. Social visits will be limited to one (1) hour, as to allow all inmates two (2) opportunities per month to receive visitors.

At the Federal Prison Camp (FPC), social visits will be conducted biweekly on Tuesday and Wednesdays, 8:30 a.m. to 2:45 p.m. Social visits will be limited to one (1) hour, as to allow all inmates two (2) opportunities per month to receive visitors.

All social visits must be approved in advance by Unit Team. Inmates will contact their Unit Team to request a visit on their designated visitation dates. Potential visitors should contact the inmate they intend to visit to determine which unit or facility they are assigned to and to select a desired visit

time. All visits will commence at 8:30 a.m., 10:15 a.m., 12:00 p.m, or 1:45 p.m. Processing of inmate visitors will begin 15 minutes prior to the start of each one (1) hour visitation period. Visitors who arrive after the 15 minute processing period will be denied entry. Visitors will complete the standard visitation form BP-A0224; Notification to Visitor, as well as, a COVID-19 symptom checklist in their vehicle. Visitors will remain outside the lobby until called by the officer. Visitors refusing, or failing, to comply with any part of the screening process will not be allowed entry.

All visitors will be subject to enhanced COVID-19 screening and a temperature check. Any visitor exhibiting signs of COVID-19, are symptomatic, or has a temperature 100.4 degrees or higher will be denied access to the Visiting Room. Any visitor who refuses to comply with these enhanced screening procedures will be denied access.

All inmates and visitors will be required to wear proper face coverings at all times. Face coverings must be solid in color, contain no writing, and must cover the nose and mouth. Bandanas, balaclavas, handkerchiefs, neck gaiters, or vented masks are not approved face coverings.

Social distancing barriers have been placed in the visiting room to mitigate the possible exposure to the COVID-19 virus. Social distancing must be adhered to by all inmates and visitors.

FCI Danbury is following the Department of Public Health COVID-19 guidelines for the State of Connecticut. All visitors will need to check the website for specific guidance for the State of Connecticut on COVID-19 procedures, as they are updated weekly. <http://www.ct.gov/dph>.
